The team met up in the parking lot of an old store in White Deer, PA. We waited for Pat and Pam Celli to arrive so we could conduct the Invocation of Protection, a ritual we have begun to use as part of our "pre-investigation" warm up. After Pat and Pam (our group Clairvoyant) arrived, we left for the home of Debbie Bieber.

When we arrived at the home, there were many people awaiting us. This disturbed me and other members of the group as we felt like we have become entertainment. We proceed as per normal and gathered the gear. After getting the gear together, we proceeded to the basement.

Upon entering the basement, I used an EMF detector to scan the basement for EMF Readings. The only objects that set off the EMF detector were the Power box, the junction box, and the electrical components of the heating system. I scanned the basement thoroughly, as did Pat Celli. Ernie then called for the EVP sessions to begin.

As we began to conduct the EVP session, I noticed that Ralph was attempting to do some provoking of the entity that from our last session seemed to have some disdain for him. Taking Ralph's lead, I also began to provoke the entity. Upon asking the entity of being jailed by Ralph, Adam's EVP meter spiked to the red. Seems like we hit a nerve with whatever resided in there. Noise from above forced us to end the first EVP session.

During the intermission between sessions, Pam provided us with information that she gathered from these entities. It seems that the negative is named "Jason" and he is holding other entities in the basement. He is a nasty fellow, and from information gathered, liked to torture babies. Being disgusted, but knowing that people do not like to be reminded of past crimes – I used this information as a tool of provocation during the second EVP session.

We began the second EVP session, with Ralph and I again provoking. When I asked the entity to stand before me; my meter went off slightly. It did this each time I asked it to show me a sign. Once again, Ernie asked about Jail – and Adam's meter went off to the red, and made a noise that caught my attention. After a few more minutes, we ended for the night.

The team packed up the equipment, and Pam doused us all with White Sage to cleanse us of any attachment. For the rest of the night I was highly agitated.

Upon making it home, I went to bed. As I laid in bed – I heard footsteps in my attic and in my upstairs hallway. I brushed it off.

Sunday – I awoke to find myself very weak. I was so tired, that I took a nap, which is very uncharacteristic of me. I do remember having a dream that disturbed me. Jason had come to me in my dream and attacked myself, Ernie, and Adam. I cannot remember what he looks like, just something dark and menacing. I can tell you that he does not like us- nor does he care for us prodding around in his business.

This week I have been very weak, and now I have come down with a mild flu. It's going around, but one can't be too sure.
